## WARM-FM'S "MOTHER'S DAY MINI ME PHOTO CONTEST" CONTEST OFFICIAL RULES

The Station will conduct the **WARM-FM's "Mother's Day Mini Me Photo Contest"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.

Eligibility. This Contest is open only to legal U.S. residents of the Station's Designated Market Area ("DMA") as defined by Nielsen Audio, excluding Florida and New York residents, age eighteen (18) years or older at the time of entry with a valid Social Security number, who have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months, and whose immediate family members or household members have not won a prize from the Station in the last thirty (30) days or a prize valued at \$500 or more in the last six (6) months. The term "household members" refers to people who share the same residence at least three (3) months out of the year. The Contest is subject to all applicable federal, state and local laws and regulations. - 2. Contest Period. The Contest entry period will begin at 7:00 a.m. ET on May 1, 2023 and will run through 3:00 p.m. ET on May 11, 2023 (the "Contest Period"). The Station's computer is the official time keeping device for this Contest.
- **3. How to Enter.** Visit the Station's Facebook page at www.facebook.com/warm1033 during the Contest Period. To complete your entry in the contest, post a photo of yourself and your child (or children) in the comments section on the Mini Me Photo Contest post.

Any entry comments that are indecent, lewd, offensive, defamatory, contain profanities, or are in any way in bad taste or contain material that may infringe or violate any laws or anyone's rights, as determined in the sole discretion of the Station, may be disqualified. Entry comments that are removed and/or blocked by Station and/or by Facebook will be deemed not entered in the Contest.

All entries must be received by 3:00 p.m. ET on May 11, 2023 to be eligible for a chance to win a prize. **Limit one (1) entry per person.** Use of any automated system to participate is prohibited and will result in disqualification. Station is not responsible for lost, late, incomplete, invalid, unintelligible, inappropriate or misdirected registrations, all of which will be disqualified. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the entrant. The "authorized account holder" is the natural person assigned the telephone number by the wireless carrier or an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winner may be required to show proof of being the authorized account holder. All entries become the sole and exclusive property of Station and will not be returned. Station reserves the

right to contact entrants and all other individuals whose email address is submitted as part of this promotion. No mail-in entries will be accepted.

This Contest is in no way sponsored, endorsed, administered by, or associated with Facebook. By submission of an entry, an entrant releases Facebook from any responsibility or liability for the Contest's administration, prizes, or promotion. An entrant is providing entry information to the Station and not to Facebook.

- 4. Winner Selection. On or about 3:00 p.m. ET on May 11, 2023, Station will select one (1) potential winner in a random drawing from among all valid entries received by Station during the Contest Period. The winning entrant will be contacted using the email address and/or telephone number provided with the entry and may be awarded the prize (subject to verification of eligibility and compliance with the terms of these rules). Station's decisions as to the administration and operation of the Contest and the selection of the potential winner are final and binding in all matters related to the Contest. Failure to respond to the initial verification contact within three (3) days of notification or failure to claim the prize within three (3) days of verification and forfeiture of the prize.
- Verification of Potential Winner. THE ELIGIBILITY OF ALL POTENTIAL CONTEST WINNERS 5.
