WARM-FM'S "JUSTIN TIMBERLAKE REGISTER TO WIN" CONTEST OFFICIAL RULES

The Station will conduct the **WARM-FM's "Justin Timberlake Register to Win"** Contest (the "Contest") substantially as described in these rules, and by participating, each entrant agrees as follows:

- 1. NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED. ALL FEDERAL, STATE, AND LOCAL REGULATIONS APPLY.
 - Eligibility.
